Mabe Parish Council

Minutes of the meeting of Mabe Parish Council held on Thursday 14th July 2016, at the Mabe WI Hall, at 7.30pm

Representatives from University of Exeter, Falmouth University and Falmouth Exeter Plus were unable to attend the meeting to speak with the members concerning plans at Penryn campus regarding growth; this has now been deferred to the September meeting.

Mr Norman Trebilcock from FLEET and Mr Keith Bryant who has been fundraising to buy a defibrillator for Mabe, attended to give members information and a demonstration regarding agenda item 10 – Defibrillator. Main points: £3100 cost per machine, enough raised to purchase one machine, hope to be able to raise enough funds for a second, cost of electricity is 0.03p per day to run, free installation, yearly cost of £295 + VAT, £105 per set of replacement pads, although it is likely that FLEET would replace FOC (new pads needed after each use). Machine connected to Ambulance Control who would release the lock when applicable 999 call made.

Present: Parish Councillors A Thomas (Chairman), R Phillips (Vice-Chairman), J Frost, B Hewett-Silk, A Hocking, F Miller, S Nisbet, B Steptoe, P Tisdale, Cornwall Councillor P Williams, F Collins (Parish Clerk) and four members of the public.

- 1. Apologies for absence were received from Cllr T Kingsley
- 2. Declarations of interest in Agenda Items Cllr Hewett-Silk, item 9C (neighbour).
- **3. Minutes of Previous Meeting** the minutes of the meeting held on Wednesday 8th June 2016 were held as a true and correct record, subject to two minor amendments.

- 4. Matters Arising from the meeting held on Wednesday 8th June 2016
- Cllr Miller raised the matter of the awarding of £1000 to St Laudus Church towards the maintenance of the churchyard. He stated that he had been under the impression that the precept was raised for this year 2016/7 to cover a higher amount of donation, but was informed that the precept had been raised to cover last year's increase, as well as other expected costs. Cllr Miller addressed other matters that were stated as reasons for the lower amount; three quotes were obtained for the work, the income from burials is a set amount laid down by "canon law" and cannot be increased, also the yearly amount is variable.
- Cllr Tisdale informed members that he had recently emailed around to everyone regarding a Carnsew Quarry matter, and needed replies urgently, yet had not received any. He requested that members reply to such matters in future, using "reply all" so that everyone is included in the conversation.

5. Public Participation

- Mr Kessell attended the meeting and stated his concerns regarding a Pre-app for housing behind Coronation Cottages. He is of the opinion that it would be an ideal location for a new school. Cllr Tisdale informed him that there are plans to provide three extra classrooms at the current site which would double the size of the school and pupils.
- Mr D Fields attended re 9b, his planning application.
- Mr K Bryant attended regarding a Highways matter, requesting that zigzags be painted outside the MYCP entrance as they are at the school. Cllr Williams to investigate whether this would be possible.
- 6. Report from Cornwall Councillor Williams

- Cycle track work at Treliever Roundabout coming to an end. He had wanted the University crossing to be installed at the same time, but it did not prove possible.
- Traffic lights at Kernick to be operational only between 9.30-3.30.
- Footpath by MYCP Cllr Williams wanted to know the Parish Council's view on this and was informed that the last time this was discussed members had requested for a quote be given with accurate figures, rather than an estimate/guide price. He stated that this was not possible, but strongly feels that this matter needs to be dealt with, and decided as else the s106 monies could be lost. After discussion, it was decided to add this as an agenda item at the next meeting in August.
- Cllr Williams has been contacted by CC Planning Department regarding the houses at Antron Hill (see 9g on June agenda PA15/09659 Land north side of Antron Hill, Penryn, TR10 9HH Porthminster Beach View Ltd), he will not sign this off, as he is of the opinion that Local Needs housing should be provided at the site, as per the original application.

- 9. g Planning matters arising since 6th July 2016 members had been circulated an email from the architects that have been employed to examine the potential development opportunity of land close to Treluswell/ Four Cross, Penryn to provide a new student village. The development is in St Gluvias parish, but is right next to the border with Mabe. They have said that they would like to arrange a joint meeting with members of the St Gluvias, Mabe and Penryn Parish Councils to present and discuss the proposals, concurrently with public consultation on the scheme. Their intention is to host a three hour public exhibition, either preceding or following this meeting as determined by the availability of Parish Council members. Members discussed the matter and asked that the Clerk reply to say that Mabe Parish Council request that a separate consultation is held in the parish.

- 10. Mabe Pad Appeal 2016 -Defibrillator to consider letter from Mr Keith Bryant re Parish Council acting as the recognised body to administer/fund the account (N.B. Mr Norman Trebilcock from FLEET attended ahead of the meeting regarding this matter, see previously for further details. Members agreed to act as the "recognised body to administer/fund the account". They agreed that this should be reviewed after five years. Clerk to seek

confirmation whether this year's fee is included in the original cost of the defibrillator or whether is due this year. **Proposed:** Cllr Phillips **Seconded:** Cllr Tisdale.

- 11. To consider quotations received to remove trees from behind the bus shelter following further information required from the May/ June meetings Members agreed that Greens Grounds & Trees be appointed to carry out the work of the partial removal of the trees behind the bus shelter, as per their quote dated 10th May 2016.

- 12. Neighbourhood Plans Cllr Hewett-Silk informed members that she had attended a Community Network Panel meeting where the matter of Neighbourhood Plans had arisen. She stated that she felt that the parish would have a greater say in what planning applications were passed if one was in place. Members informed her that the matter had been discussed in the past, but had concerns regarding the cost (£20-30,000), the amount of work involved, and the validity of them. Cllr Hewett-Silk to make further investigations regarding the matter (Clerk to pass on a Penryn TC contact), and report back.
- 13. Traffic/Highways no business.
- **14. Falmouth University Business & Penryn Campus Report –** the Clerk reminded members that there is to be a public consultation on Wednesday 20th July, to be held in the WI Hall from 12noon until 6pm.
- **15. Protocols for Parish Grants** Cllr Hewett-Silk stated that she had concerns regarding the manner in which Grants were awarded. She would like to set criteria for all applications. Cllr Phillips stated that he thought that the application form should also be amended, as is not straightforward to complete. Members agreed that this would be discussed at the October meeting. Cllr Hewett-Silk to obtain other application forms/criteria as examples for discussion.

Colas Quarry has asked again for a meeting to be held with the liaison members – a date of 20th July, at 9.30am was set, Clerk to inform.

17. Matters of concern

- Cllr Tisdale rubbish on A394
- Cllr Frost enquired whether Brexit would have an impact on parish council funding. It was thought not.
- Cllr Hocking concerns regarding Antron Lane-Church Road blind bend, thinks there should be a "concealed entrance" sign up, as it is very dangerous. Cllr Tisdale to speak to Viv Bidgood from Highways.
